Montgomery County Juvenile Court-CYPM \$15,000
Partially funds a half time scheduler for the Cross-Over Youth program during this implementation year.

University of Dayton-Clinical Traineeship Program \$15,000
Provides stipends to allow internship opportunities for Master’s level psychology students.

Suicide Prevention Center \$20,000
Gatekeeper training workshops provides eight half day workshops to ADAMHS provider agencies and "gatekeepers" such as law enforcement, fire, EMS, schools, businesses, medical community and faith based organizations. Provides one advanced course for more experienced professionals.

ICAT Coordinator \$25,484
This is a cost share with Juvenile Court and CSD for the position of ICAT Coordinator.

WSU DD/MI Professorship Program \$30,000

Partial support toward the salary of a Faculty Position who provides clinical services and supervision to psychiatry residents and medical students in CMHCs. Faculty is a Psychiatrist with DD/MI expertise whose goal to increase psychiatric workforce competency with dual DD/MI clients.

National Alliance for the Mentally Ill of Montgomery County (NAMI) \$52,262

Provides community, family and consumer education and support. New for SFY 14 is expansion of programs that serve youth ages 8-19 who have a new diagnosis or who have a parent or sibling with a MH diagnosis.

WSU SOPP \$62,000

Provides stipends for doctoral students to support training 12 students.

WSU PECE-PACT \$69,288

Prevention program for parents and youth to enhance parenting skills, reduce substance use and abuse and prevent child abuse and neglect.

Friends of the Castle \$73,832

Social club that provides on a drop in basis socialization & recreational opportunities for persons with severe mental illness. Expanding program in SFY 14 to include a recovery club option for members.

WSU Child Psychiatric Placement/MVH \$75,000

Funding supports child psychiatric residents who are working in the ADAMHS system of care.

Public Health HIV Outreach Program \$77,428

Provides street outreach to persons at risk of developing HIV due to IV drug use and lifestyle choices. Seeks to link persons to treatment and provide education.

Children's Medical Center Autism Psychiatric Clinic \$100,000

Support a multi-system partnership to expand psychiatric access for youth with autism spectrum diagnosis via support to psychiatric clinic operated by CMC in partnership with DDS, ADAMHS, CMC, WSU SOM and CMC.

Sinclair Community College \$113,526

Supportive education counselor positions (1.59 FTE) who assist students with a documented mental disability via academic counseling. Serves 400 students per term.

Life Essentials \$205,486

Provides Guardianship services to those persons with severe mental illness who have been found incompetent.

Recovery Centers Inc. \$241,458

Residential level of care for women with a substance use diagnosis, including IDDT treatment for dual diagnosed clients.

Senior Resource Connection \$298,770

Payee program to 393 SMD, SPMI persons.

WSU Consumer Advocacy Model (CAM) \$477,634

CMHC that targets persons with a co-occurring physical disability. Provides services to deaf, hard of hearing consumers.

Miami Valley Housing Opportunities (MVHO) \$565,024

MVHO provides 368 apartments in 41 locations to 675 people with a disability including mental illness. PATH- homeless outreach targeted to the mentally ill on the street. New Hope Villa provides housing, meals, laundry, and supportive services to 20 SPMI age 50 and over.

Public Health Center for Alcohol & Drug Addiction Services (CADAS) \$1,043,049

Provides alcohol and other drug treatment services to adults in the form of SOP and IOP programming. Provides prevention services to targeted populations that include pregnant women, IV drug users, court involved parents of preschoolers, and CSD involved families.

PLACES \$1,416,333

Housing and supportive living services program for adult SPMI and co-occurring DD clients who meet the level of care.

South Community Behavioral Health \$2,536,570

Outpatient CMHC providing MH services to all ages. Provides traditional MH services as well as supported employment, IDDT, ACT services, BHJJ/LIFE program, youth partial hospitalization, youth intensive summer programming and treatment foster care services. New in FY 14 is the addition of an autism program to assist families with children on the

autism spectrum who need system navigation and support services, as well as the addition of Suboxone services in early 2013.

NOVA Behavioral Health

\$4,658,452

Residential level of care for adult men and women with a substance use diagnosis, including an IDDT unit for dual diagnosed clients. Provides 41 beds as well as outpatient and aftercare services to adults. Morningstar program is a 16 bed Type I Residential facility for SPMI to prevent hospitalization or for post hospitalization step down and monitoring.

***Family Services Association**

\$40,400

Provides treatment and prevention services to GMH & SMD population adults & youth including a specialized program for deaf clients.

***UMADAOP**

\$53,694

Prevention agency. Providing ATOD, violence prevention and parenting skills training to youth ages 12-18 years of age and their families.

***Goodwill/Easter Seals**

\$90,128

Supported employment program for SMD clients.

***UHS**

\$123,336

Prevention agency providing services targeting pregnant and parenting adolescents and young adults up to age 22 and their families. Also provides services in 12 schools/community locations targeting youth ages 9-19 towards risk reduction, ATOD avoidance and prevention education.

***Project CURE**

\$964,665

HIV Early Intervention Program & Medication Assisted Treatment provided in an Opioid Treatment Center dispensing Methadone with outpatient treatment services for adults.

***Day-Mont BH**

\$1,540,920

Outpatient CMHC providing MH and non-intensive AoD services to adults and youth. Provides traditional MH services as well as supported employment program, IDDT and ACT services.

***Samaritan Behavioral Health Inc.**

\$2,777,242

Counseling and Treatment Center receives \$190,322 towards CATT Program that serves 0-6 years olds & their families identified in partnership with daycare centers; 404 BH funds target indigent youth & their families who are aged 6 years and up and are Children Services involved; \$20k claims based traditional BH services including Diagnostic Assessments, Individual, Group, Family Therapy, Pharm. Management, CPST services. New in SFY '14 is a BH/Primary Care Integration program targeted in the Five Rivers FQHC serving any patient identified as needing brief intervention services; Psychiatric Consultation services by one adult and one child psychiatrist to ten Primary Care Physician office sites.
